



Bazar, dawr leh sumdawnna hmunte:

- 1) Dawr leh sumdawnna hmunah te hian dawrtu te hming, contact number leh address chhinchhiahna tur register ruahman ngei ngei tur a ni.
- 2) Dawr leh sumdawnna hmuna social distancing kenkawh hi dawr/sumdawnna neitu mawhpurhna a ni a. Chuvangin dawrtu te an in tlar a tul changin social distancing an zawm ngei na turin dawr neitu ten ruahmannan a siam tur a ni. Tin, dawrtu te tan hand sanitizer an chhawp ngei ngei tur a ni.
- 3) Loh theih loh a nih loh chuan leh a hmunhma in a zir lo a nih loh chuan dawr chhungah dawrtu te luh tir loh tur a ni.
- 4) Indawrna ah pawisa inhlanchhawn tawn a ngaih loh nan mamawh leina tur zat in ruahman thin nise.

Petrol Pump/Filling station:

1. Petrol pump, a kal ten social distancing uluk taka zawmin face mask an hmang ngei ngei tur a ni. Social distancing zawm chungchangah pump/filling station neitu ten mawh an phur ang.
2. Pump/filling station neitu ten anmahni dawrtu te hman tur hand sanitizer an chhawp ngei ngei tur a ni. Tin, two-wheeler leh bur(gallon) hmanga petrol/diesel la ten hand sanitizer an hmang ngei ngei tur a ni.


