He hri laka him tura kalphung dik inzirtirna'n **No-Tolerance Drive** neih a nih hnuah COVID-19 hri lêng kâra invên fimkhurna châng mipuiin kan hriat tawh beisein, invêng fimkhur tak chunga nunphung pangngai kan neih chhonzawm leh hi a tûl avangin Sorkar hian inkhuahkhirhna rip zual a phelh dul mai a ni a. **Tunah hian a hma aiin he hri laka kan himna'na mi tinte mawhphurhna hi a tam zâwk tawh tih hriat t̄heuh tur a ni.**
2. Chuvangin, COVID-19 hri laka kan him tlân zelna'n he'ngte hi uluk taka zawm zui zel tur a ni.-
  - (1) Vantlang hmun leh mi dangte bula awm laia **mask vuah, chil chhâk loh** leh **social distancing vawn** uluk tur tihte;
  - (2) **Office** leh **Dâwr** leh **mipui punkhawmna programme** neihna apianga **Sanitiser** chhawp/ hman leh, a tlawhtu (Visitor) te hming leh mobile number ziah (**Visitors' Register vawn**) zel tur tihte;
  - (3) Sorkar Order zâwm chung zel chauhva mipui punkhawmna programme huaihawt tur tihte;
  - (4) **COVID-19 hri vei niâwma inringhlel** chuan Health Dept. mite hnena in-report nghal zel tur tihte,
  - (5) **Swab Sample lâk leh test** a nihin, **negative result** nei tih inhre hmasa lo chuan chhuahvah hauh loh tur tihte leh
  - (6) COVID-19 kaihhnawiha **Sorkar thupêk awm apiangte.**
3. A chunga tar lante leh **Mizoram (Containment and Prevention of the Spread of COVID-19) Act, 2020** dânte hi he dânin thuneihna a pêk te'n mahni bial chhungah kenkawha, fimkhur tura mipuite zirtir zui zel tur a ni e.
